Transport Policy for service users of Adult Social care

2. What is the purpose of the policy/ service change?

To review and minimise the provision of funded transport for service users of adult social care through a new assessment framework. This will result in a significant cost saving to the council and:

Help move towards a consistent and equitable approach to funded transport, specifying an open and transport eligibility process.

2. Legal Framework

Newport City Council has a duty to provide transport to users of services in certain circumstances set out in:

- Section 29 of the National Assistance Act 1948
- Section 2 of the Chronically Sick and Disabled Person Act 1970.
- Section 47 of the National Health Service Community Care Act.
- The Carers (Equal Opportunities) act 2004
- Social Care Charges (Wales) Measure 2010
- Local Authority Social Services Act 1970
- Carers and Disabled Children Act 2000.
- Social Care Charges (Means Assessment and Determination of Charges) (Wales) Regulations 2011
- Social Care Charges (Direct Payments) (Means Assessment and Determination of Reimbursement or Contribution) (Wales) Regulations 2011

The Policy has been formulated after giving due consideration to the Council's duties under the Equalities Act 2010. The Council is aware that there is a need to:

- Eliminate discrimination, harassment, victimisation and other conduct prohibited by the Act
- Advance equality of opportunity between those individuals who share a relevant protected characteristic (this Policy is particularly relevant to those who have the protected characteristic of age or disability) and those individuals who do not share it

- Foster good relations between those who share a relevant protected characteristic and those who don't. The Policy also takes account of the need to eliminate discrimination against those individuals, like carers and family members, who may be affected through their association with older or disabled people.
- Mitigate any adverse impacts if individuals are identified as not needing further assistance with transport.

Adult social care services are facing considerable challenges. People are living longer meaning that there are higher proportions of older people across our communities. People are living longer with complex conditions, dementia and chronic illnesses. The way that all councils across Wales provide social services is also changing. Through legislation such as the Social Services and Wellbeing Act (Wales) and The Future Generations Act the council is changing the way in which it responds to need.

We want to provide individuals with:-

- More choice and control over the services they receive;
- Spend more time listening to their views and feelings;
- Opportunities that treat people with respect; and are flexible allowing for people's different cultures, beliefs, language needs and other issues
- Access to universal services including transport, leisure, training and employment
- Opportunities to be part of their local and wider community and to have support from friends and family;
- Help to stay independent for as long as possible.

6. How will the relevant groups be advised of the changes and the F&EIA?

The policy and changes will be subject to a consultation process to include individuals, their families and key stakeholder groups. This will include open for a with relevant officers of the council and other interested parties. The consultation will be published on Newport City Council's website and consultees will be invited to respond and put forward any ideas or suggestions about alternative solutions to some of the challenges raised as a result of the policy.

7 How will the policy/ practice make Newport more or less fair in relation to:

- Health Inequalities
- Child Poverty
- Skills and Work
- Tackling Domestic Violence
- Alcohol and Substance misuse
- Homelessness
- Armed Forces Veterans

Some of these groups above may be experiencing physical disabilities or mental health issues. Transport for service users is also provided to support people to access educational and skills development opportunities so there is a potential impact on their ability to access these. The aim of the policy is not to negatively impact on these groups but to provide a more fair and equitable approach and to give users choice and promote independence. Whilst initially there may be the perception of a negative impact on the affected individuals, the aim is to make the provision of transport fairer and in line with the new Social Services and Well Being Act.

8. How will the service / policy affect local areas of the city?

Will it have a positive or negative impact in terms of fairness and addressing local area deprivation (you will need to use spatial data available through the Newport Profile and specific Ward Profiles to address this question)?

This change seeks to promote a fairer and more equitable approach to the provision of transport and provide choice to service users to access more local community based services. This links to the empowerment approach of Communities First / Community Development who will be supporting the implementation of this policy through assisting with travel training etc. There is no negative impact on local area deprivation.

9. In summary, how does the changed service /policy promote good community relations (cohesion)?

This policy will help to foster good relations between those who share a relevant protected characteristic and those who don't. The Policy also takes account of the need to eliminate discrimination against those individuals such as carers and family members, who may be affected through their association with older or disabled people.

This policy will help service users who share a protected characteristic to be more independent and integrate into the wider community, making use of mainstream transport options and breaking down barriers with the general population. It is anticipated that this will create a greater understanding of the issues faced by people with disabilities and promote a more cohesive community.

10. In summary, how does the changed service /policy promote equality?

This policy aims to promote equality through:

- Promoting independence
- Maximising choice and control
- Supporting a healthy lifestyle
- Improved quality of life
- Maximising dignity and respect
- The provision of local accessible services and support

We believe that the introduction of this policy will provide a more fair and equitable service to all by:

- Advancing equality of opportunity between those individuals who share a relevant protected characteristic (this Policy is particularly relevant to those who have the protected characteristic of age or disability) and those individuals who do not share it
- Fostering good relations between those who share a relevant protected characteristic and those who don't. The Policy also takes account of the need to eliminate discrimination against those individuals, like carers and family members, who may be affected through their association with older or disabled people.
- Mitigating against any adverse impacts that may affect individuals who are assessed as ineligible for transport.

11. In summary, how does the changed service /policy eliminate discrimination?

Individuals will be assessed according to their need, with a full risk assessment which will ensure that there is equity within the decision making process.

This policy supports people to lead more independent lives and exercise choice. It will aid integration into the wider community, breaking down barriers and promoting understanding within the wider community thereby reducing discrimination.
