Overall, the change of use of the existing C3 Dwellinghouse to a C4 HMO is unlikely to raise significant concerns in principle from officers insofar as impact upon character and appearance of area is concerned (although it is highly likely such an application will not be determined under delegated powers). This assumes that concentration remains the same and there are no hostels or HMOs close by or added to the 50m radius that may contribute to clear social cohesion or anti social behaviour concerns. Gwent Police will be a consultee of any planning application.

I would consider the 5no. bedroom option as being overdevelopment of the site as it would result in an insufficient open plan kitchen and lounge area that would not provide adequate amenity for future occupiers. The 4no. bedroom option would be acceptable in this regard. It must be demonstrated that the increase in on street parking can be accommodated safely through the submission of a Parking Survey and it must be demonstrated that flood risk can be managed through the submission of a Flood Consequences Assessment.
