All flats are considered self-contained, regardless of whether they are a studio apartment or not.

You should get in touch with the Regeneration Team to find out what their criteria is in order to receive a grant.

With regards to the kitchen placement, we don't typically offer informal advice on schemes without a pre-application advice enquiry, however this placement is likely to go towards overcoming the identified issues. Please note that all other issues would need to be overcome to gain consent.

To determine the acceptability of UPVc and Solar Panels, a pre-application advice should be submitted, full details of materials should be submitted if submitting a full application.
