Please note that the acoustic fence is 2.4m high **with timber posts, rails and close boarding.**

I have been informed that the feature wall detail is still subject to discussion that could take some time. Would it be possible to have a 'partial discharge' on the gabions and put the Feature wall (etc.) in on a separate discharge application? It is hoped that the works for the gabions can proceed in a few weeks following your agreement.
